A contract between us will come into existence when we process your deposit or initial payment into our account, at which time we will either issue a deposit receipt letter acknowledging the acceptance of your booking or, in the case that all arrangements can be confirmed at that time, a confirmation invoice ("Confirmation Invoice"). Whether or not we have received your booking details prior to processing your deposit or full payment will not affect the formation of the contract.

The deposit is non-refundable, and will amount to at least 20% of the total price of your holiday (the "Deposit"). In certain circumstances we may require a higher deposit and you will be advised of this at the time of booking. In the event that we are required to make full payment in advance of your holiday to a supplier for any services requested by you, in order to secure such arrangements we may invoice you immediately for the full amount of that element of your holiday and payment will be due forthwith. In the event that the balance is not paid within a reasonable time and in any event not later than 8 weeks prior to departure, we reserve the right to cancel your holiday. Should payment of the Final Invoice not be made within 8 weeks of departure, the Deposit will be forfeited. Where an additional up-front payment has been paid on top of the deposit, and in advance of our standard payment schedule, in the event of non-payment of the Final Invoice this will be treated as a part of your non-refundable deposit.

Please check your invoices, confirmation and all other documentation pertaining to your travel plans carefully upon receipt and contact us immediately if any information appears to be incorrect or incomplete as it may not be possible to make changes if we are not notified immediately. We regret that we cannot accept any liability if we are not notified of any inaccuracy in any document within 14 days (5 days for tickets) of our sending it to you. We will do our best to rectify any mistake notified to us outside these time limits but any costs involved in doing so will be invoiced to you accordingly, unless the mistake in question was made by us. was made by us.

2. THE PRICE OF YOUR HOLIDAY

We reserve the right to make changes to and correct errors in advertised prices at any time before your holiday is confirmed. You will be advised of any error of which we are aware and the correct price prior to the time that your holiday is confirmed by us.

Once the price of your chosen holiday has been confirmed fat the time of booking], this is final. Please note however that we guarantee not to impose any surcharge on you if you have paid the full balance of the cost of your holiday at the time of booking and the remaining provisions of this clause will not apply. In the unlikely event of changes to the booking price will only be made in the circumstances set out below.

In these circumstances, you have 14 days from the issue date printed on the Surcharge Invoice to tell us if you want to cancel or purchase another holiday. If you do not tell us that you wish to do so within this period of time, we are entitled to assume that you will pay the surcharge. Any surcharge must be paid with the balance of the cost of the holiday or within 14 days of the issue date printed on the Surcharge Invoice, whichever is the later.

3. ALTERATIONS BY YOU

We will not cancel after this date for any otherreason.]

Most changes are minor. Although extremely unlikely, if any situation as stated in Clause 10 does occur, we regret we will be unable to make any refunds (unless we obtain any refunds from our suppliers), pay you any compensation or meet any costs or expenses you incur as a result.

NB. If your flight is cancelled or delayed, your flight ticket is downgraded or boarding is denied by your airline in circumstances which would entitle you to claim compensation against the airline, you must pursue the airline for the compensation due to you. All sums you receive or are entitled to receive from the airline represent the full amount of your entitlement to compensation or any other payment arising from such cancellation, delay, downgrading or denied boarding. This includes any disappointment, distress, inconvenience or effect on any other arrangements.
